
What is Copy Protect?

Options:

Copy Protect lets you customize default quality conversion and format settings of your audios and videos based on the available size in the medium where you want to save or burn these files. You can access these options after adding files that you want to protect.

This screen of 'Set Security' has these columns:

Output Filename: Filename is editable so that if you want to change it you can easily do so.

Video Conversion: Two methods of video conversion are available i.e.; secure and highly secure that you can select from the drop-down list. By default secure method (fast) of video conversion is selected, however users can also select highly secure method.

Audio Bit Rate: Here you can change the bit rate for your audios from the drop-down menu.

Video Bit Rate: Here you can change the bit rate for your videos from the drop-down menu.

ETA – Time: This is the estimated time required to convert your media files into copy protected applications which is dependent on the video conversion method.
